I hereby purchase a non-transferable membership from Match Point Tennis Academy LLC, located at the Cabrillo Tennis Center, 800 Cabrillo Park Drive, Santa Ana, California 92701.

I understand that the **initiation fee** is a one-time charge if I have a continuous membership. If I go inactive or terminate, a new initiation fee will apply for my membership. If I renew my Annual Membership within thirty (30) days of its expiration date, I will not be charged again for an initiation fee. I understand that if during the 7 days following this purchase I am not fully satisfied, I can cancel this membership by notice in writing to Match Point Tennis Academy and receive a refund of the full amount of my initiation fee and any membership dues paid.

I understand that my membership does not give me any ownership rights to Match Point Tennis Academy or its property and that I have only the right to use the facilities subject to the rules of Match Point Tennis Academy, which rules are subject to change without notice. Dues are subject to change on a thirty day notice and prices on all memberships are guaranteed for one year only.

I have the right to **terminate** this membership at any time by giving 30 days written notice to Match Point Tennis Academy, which is accompanied by payment in full of all charges then due by me to Match Point Tennis Academy. If I terminate before my full year is complete, I will be charged the regular monthly fees and forfeit any yearly special prices. I understand that Match Point Tennis Academy has the right to cancel my membership if my account becomes more than 30 days delinquent and I will be liable for all dues, fees, and charges for the remainder of my membership term even if I am not using the facilities.

I understand that I may apply for an **inactive status** only if I have a Monthly Membership and I make my request in writing. If I am granted this inactive status, I will be charged each month one-third (1/3) of the monthly fee until I reactivate.

I, the undersigned do hereby release Match Point Tennis Academy and the City of Santa Ana and all its officers, employees and independent contractors, acting within the scope of this employment of an liability for damages arising from any personal property loss or any bodily injury received by me or any of my children while participating in the said facility services, programs, or classes.

In case of an accident or an emergency, I authorize Match Point Tennis Academy to call emergency 911 in order to take me to the nearest emergency hospital for such emergency treatment and measures, at my expense, that are deemed necessary.

I have read the academy policies, rules, and conditions for Match Point Tennis Academy membership, on both sides of this document and I hereby agree to comply with and be bound by it.
